RELEASE, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT

We agree on behalf of ourselves, our Athlete, and any heirs or assigns to release, hold harmless, and indemnify of Roswell Gymnastics, its current and former officers, directors, employees, or the College Showcase, and the College Showcase owners, officers, directors and employees from and against any and all claims and liability or damages of any kind or nature whatsoever arising out of or relating to the Activity/Event.
